OFFICIAL RULES AND REGULATIONS

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE ODDS OF WINNING. VOID WHERE PROHIBITED.

SPONSOR: Travel Guide, LLC d/b/a HotelCoupons.com

By participating in the HotelCoupons.com Travel Inspiration Contest (the “Contest”), you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

CONTEST PERIOD. HotelCoupons.com Travel Inspiration Instagram Contest (the “Contest”) begins at 8:00 am Eastern Daylight Time (“ET”) on August 21, 2017 and ends at 11:59 pm ET on August 27, 2017 (the “Contest Period”). All entries must be received during the Contest Period to be eligible to win a prize.

ELIGIBILITY REQUIREMENTS. The Contest is open to legal residents of the fifty (50) United States and the District of Columbia who are age eighteen (18) years old or older (or the age of majority in their state of residence) as of the date the Contest begins. This offer is void wherever prohibited or restricted and subject to all applicable federal, state, and local laws. Employees and their immediate family (parent, child, sibling and spouse of each) and individuals residing in the same household (whether or not related) of Dominion Enterprises, Landmark Media Enterprises, LLC, and any of their affiliates, subsidiaries, advertising and promotion agencies, and all other entities or individuals associated with the development, administration, or fulfillment of the Contest are not eligible to participate or win. Entry Method 1:

1. Entry via Instagram: Entrants may set up a free Instagram account at [instagram.com](https://www.instagram.com). To enter the Contest, Entrants will log into their Instagram account and will upload photos or videos (the “Entry” or “Entries”) to Instagram reflecting the daily contest prompts during the Contest Period. Entries must include the hashtag #HCinspo and tag @hotelcoupons in the caption of all Entries. Entries that do not include #HCinspo and @hotelcoupons in the original caption will not be accepted. Entrants must follow @HotelCoupons on Instagram. Multiple Entries per day are encouraged.

Entry Method 2:

2. Entry via email: Entrants may submit photos or videos reflecting the daily contest prompts via email to info@hotelcoupons.com as often as daily, within the Contest Period.

ENTRY CRITERIA. Entries must comply with the following requirements to be eligible to win.

- A. In accordance with supported images, photos must be submitted as an attachment in one of the following formats: JPEGs (JPG), Non-Animated GIFs or PNGs.
- B. Entries must be the original work of the Entrant.
- C. Entrants may submit an unlimited number of Entries per day for the #HCinspo Instagram Challenge.
- D. The Entries may not have won previous awards.

- E. The Entries must not infringe upon the rights of any third-party, including, without limitation, copyright, trademark, and rights of publicity and/or privacy.

Parent or legal guardian must sign waiver and release prior to posting the image of anyone under the age of 18.

USE OF TRADEMARKS AND SLOGANS. DISPLAY OF ENTRIES. During the Contest, Sponsor will permit the Entries in compliance with the Official Rules to be displayed on its websites and/or social media network sites (the "Sites"). Entries will be reviewed for content before being posted on the Sites. Entries submitted may or may not be posted on the Sites, in the sole and absolute discretion of Sponsor. Sponsor shall have absolutely no obligation to give feedback or reasoning for why any Entry is not displayed on the Sites. Sponsor shall have the sole right to reject or remove an Entry from the Sites at any time and for any reason.

JUDGING AND WINNER SELECTION. At the conclusion of the Contest Period, a panel of judges comprised of no fewer than three (3) people with a background in marketing, social media, events, and/or

design shall determine the winner(s) from all eligible Entries received, according to the following judging criteria:

- Creativity/Originality30%
- Presentation/Image Quality.....30%
- Relevance to Daily Theme/Follows Contest Instructions.....40%

On or around September 1, 2017, Sponsor will select and post the Winners in compliance with the Official Rules on the Sites.

In the unlikely event of a tie, the Entry with the earliest upload/entry date will be deemed the Grand Prize Winner.
